### **CAR BUYER'S CHECKLIST**

### **BEFORE YOU BUY**

- Check if the vehicle is listed as stolen at <u>www.cpic-cipc.ca</u> Check for liens on the vehicle with the RPMRR via their Web site <u>www.rdprm.gouv.qc.ca</u> or phone (418) 646-4949, (514) 864-4949 or 1 800 465-4949. You will need the VIN of the vehicle and the name of the previous owner to complete your search.
- Ask to see the owner's car insurance policy to see if there is a creditor.
- Check if the vehicle was involved in a Flood, on the Flood Vehicle Database at www.nibc.org.
- Check if the vehicle was involved in a major accident at www.carproof.com
- Have the vehicle inspected by a trustworthy garage or CAA-Quebec technical inspection centre (addresses listed below). Check the chain of ownership with the SAAQ (www.saaq.gouv.qc.ca). Requests must be made in person at a SAAQ office and there is a charge for this service.
- Ask to see all recent repair bills and check to see if the repairs are still under warranty. П
- Check to see if manufacturer's warranty is still valid. П
- Check if all recalls have been carried out at www.tc.gc.ca.

### AFTER YOU BUY

- Transfer ownership at the SAAQ as quickly as possible. П
- Buyer pays the provincial tax (PST) when registering the vehicle at the SAAQ.
- Read the owner's manual carefully for information on operation and recommended maintenance.
- Advise the manufacturer that you are the new owner of the vehicle.

#### SELLER'S CHECKLIST

### **BEFORE THE SALE**

- Check to see if the prospective buyer has a valid driver's license - risk of seizure of vehicle (Tel. : 1 900 565-1212) - Fee charged for call.
- No guarantee is required of the seller in a private sale.
- The seller is liable for hidden defects. Make sure you declare all problems of which you are aware. Advise the seller if the vehicle was in a major accident.
- Accept to have the vehicle inspected at the buyer's expense by a trustworthy garage or CAA-Quebec technical inspection centre (addresses listed below).
- Show the buyer all recent repair bills.

#### AFTER THE SALE

- Transfer ownership at the SAAQ as quickly as possible.
- The provincial sales tax is payable by the purchaser when he registers the vehicle at the SAAQ.
- Make sure you give the owner's manual to the new owner. П
- Extended warranties on private sale vehicles are now available. Call CAA-Quebec for more information.
